MAJOR CONTRIBUTIONS

- Each job in oil and gas contributes \$392,000 to gross product for the Tulsa 11-county area.
- One job in oil and gas supports one job in resource-supplying companies.
- Throughout the Tulsa-area economy, one job in oil and gas supports 2.3 additional jobs across all sectors.
- Each dollar of income by an employee in oil and gas supports the earning of an additional \$1.08 throughout the Tulsa area economy.
- Each dollar of production (value added) in Tulsa-area oil and gas supports additionally \$0.55 of gross product throughout the economy.
- One year's activity in Tulsa-area oil and gas supports total sales tax of \$361 million and total property tax of \$195 million.
